Please note that project participation is voluntary and the Producer or Cellar may choose to unsubscribe at any time by informing the Vinpro Foundation. The Social Workers on the project are registered with the South African Council for Social Service Professions and their code of ethics requires that they hand over their case work (statutory related cases e.g. child neglect or abuse) to the relevant organisations/authorities. This might take time to do as these organisations/institutions are often, unfortunately, inundated with cases. By signing this form the Producer/ Cellar agrees to allow the social worker access to the farm/ cellar to complete handover of statutory cases to the relevant authorities or organisations after they have unsubscribed.
